The vision of the Association is that Judicial Independence is the cornerstone of liberty and democracy. The Association participated in drafting a number of international documents which are now recognized in many jurisdictions of the world: The New Delhi Code of minimum standards of Judicial Independence (in cooperation with the International Bar Association, New Delhi, 1982), The Montreal Declaration on the Independence of Justice (Montreal, 1983), The Mt Scopus International Standards of Judicial independence 2008, and Bologna Milano Global Code of Judicial Ethics 2015. The Association's outstanding contribution to the advancement of judicial Independence was evidenced by the Candidacy of the Association for **Nobel peace prize** in 2013. The Association was honored to be nominated for such a prize for conducting the International Project on Judicial Independence, which is the result of its almost 40 years of efforts in pursuit of judicial independence.

JIWP Association and its members introduced innovative concepts of judicial independence clarifying significant components essential for liberty, democracy, human rights and effective world trade. This was done by major international conferences of major important international organizations and drafting international standards and declarations. The concepts include the independence of the individual judge, substantive and personal, the institutional or collective independence of the judiciary as a whole, the internal judicial independence of the judge vis-a-vis his colleagues and his superiors, the principle of fair reflection of society, or judicial diversity and proper considerations and procedures for judicial selection and the careful demarcation of lines between the judiciary and the other branches of government.
